On the afternoon of March 20, 2020, Illinois Governor J.B. Pritzker issued a "Stay-at-Home" order across the State of Illinois. This went into effect at 5pm on Saturday, March 21 and lasts through April 7. Essentially the order is for 18 days and 12 working days.

The order allows for the continued operation of essential businesses only. Lawn and landscape services are essential services and permissible under Section 12. Paragraph H. of the Executive Order that reads: Critical trades. Building and Construction Tradesmen and Tradeswomen, plumbers, electricians, exterminators, cleaning and janitorial staff for commercial and governmental properties, security staff, operating engineers, HVAC, moving and relocation services, and other service providers who provide services that are necessary to maintaining the safety, sanitation, and essential operation of residences, Essential Activities, and Essential Businesses and Operations;

Outdoor landscape projects generally will provide for good social distancing that poses little risk of transmission, but it still is important to ensure the ability to wash or sanitize hands and take other precautions.
